In this case, the \$4,000 capital loss on the sale by Gibson's adult child to Gibson [\$12,000 SP - \$16,000 Basis] is disallowed. Gibson's basis is determined by his selling price to a third party. In this case, the selling price is \$18,000, which is HIGHER than the original basis of Gibson's adult child. Gibson's basis in the stock is, therefore, his adult child's basis of \$16,000. Gibson's recognized basis is calculated as follows: Choice "a" is incorrect. There would be a zero gain or loss if the selling price were between the adult child's basis and Gibson's purchase price, but this is not the case in the facts. Choice "c" is incorrect.
